AMATEUR SPORTS WAIVER AND RELEASE OF LIABILITY READ BEFORE SIGNING.

In consideration of being permitted to participate in any manner in the **Cheif Rainone Gym** (events and activities related to the Wilson Basketball League), the undersigned acknowledges, appreciates and agrees that:

1. The risks of injury and illness (including: communicable diseases such as MRSA, influenza and COVID-19) from the activities involved in this program are significant, including the potential for permanent paralysis and death and while the rules, equipment and Personal discipline can reduce these risks, the risks of serious injuries and illnesses exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL RISKS, both known and unknown, EVEN IF THEY ARISE FROM THE NEGLIGENCE OF THE RELEASEES or third parties, and assume all responsibility for my participation; and,
3. I voluntarily agree to comply with the established and customary terms and conditions for participation. However, if I observe any unusual significant danger during my presence or participation, I will withdraw from participation and report it to the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS **Cheif Rainone Gym** (Wilson Basketball League) its officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers and, if applicable, owners and lessors of the facilities used to conduct the Event ("RELEASED"), WITH RESPECT TO ALL INJURIES, ILLNESS, DISABILITY, DEATH, loss or damages to persons or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. It is Unacceptable to commit physical or verbal attacks towards the referees and/or officials of the game, including the scorers.
6. Teams that do not comply with their assigned game schedule will be responsible for paying a fee of \$40.00 per referee for a total of \$80.00. Teams that do not pay this fee risk being eliminated from the league entirely.
7. It is Unacceptable to physically attack another player, whether from the opposing team or the same one. Players involved in such practices will be expelled from the league.
8. In the event that a Player or Team is expelled from the league, there will be no refund of any kind due to that player or team.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, I FULLY UNDERSTAND ITS TERMS, I UNDERSTAND THAT I HAVE WAIVED SUBSTANTIAL RIGHTS BY SIGNING IT, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCT.
